### Terms & Conditions:

Exhibitor booths will be available for Thursday, October 31st ONLY!

1. Exhibitor booth space early registration fee is \$425 per booth. Fee for registering later than October 11th 2019 is \$475.
2. Electrical power will be provided upon request at a cost of \$10.
3. Booths will be approximately 10' x 10' and provided with an 8' wide clothed/skirted table and 2 folding chairs.
4. Exhibitor name signs for the booth will be provided.
5. Exhibitor space will be limited, and reserved on a first come, first served basis.
6. Booths will be assigned to exhibitors at random within the exhibit space; the Iowa Occupational Safety & Health Advisory Council shall have the sole discretion in booth assignment conflicts.
7. Exhibitors may set up this year on October 30th, 2019 after 5:30 PM or before 7:00 AM on October 31st 2019.
8. Registration includes lunch for one representative of your company.
9. No more than 2 booth spaces may be leased by any one company; there will be no fee reductions for leasing multiple booth spaces.
